The MPCA is offering approximately \$1.5 million in grant funding for construction and demolition management planning projects. Aiming to promote collaboration among political subdivisions, including public-private and multi-county partnerships, this funding will support regional planning efforts such as:

- Developing partnerships and integrating new programs.
- Creating efficiencies in managing C&D wastes.
- Consolidating and enhancing existing programs.
- Improving transportation networks.
- Sharing resources, services, and facilities.
- Improving economic development.

# 2025 Legislative Session Remains Unsettled

The House DFL boycott continues following a Minnesota Supreme Court ruling that House Republicans do not have quorum until 68 members are present (there are 67 Republican House members). The date for the DFL District 40B election has not been set but is likely to be in March; House DFL and Republican leaders continue to meet to negotiate an end to the stalemate so work can begin on the Constitutionally-required budget.

Doron Clark (DFL) won the special election to replace Senator Dziedzic, giving the DFL a one-vote majority. However, the current power sharing agreement remains in place until voted out, and controversy over Senator Nicole Mitchell continues to be an issue. However, the Senate is conducting business under the power sharing agreement.

AIA Minnesota and its lobbying team are following these developments closely and will continue to navigate this changing situation as best we can to advocate on the issues most important to the profession. # AGC Minnesota 2024-2025 Construction Industry Assessment Released

Thank you to the firm leaders, architects, and designers who contributed to the AGC construction industry assessment this year. An optimistic trend for the 2025 construction season is present with strong market fundamentals being held in check by the long-standing drags of a tight labor market, increased labor costs, and inflation concerns. High levels of optimism from architects may yield future opportunities in the commercial

sector; plus lower interest rates, steady project funding projections, and the adoption of new technologies are all strong positive markers for the coming year.

There is a growing move to require workers to return to the office even though a tight labor market requires employers to be creative to attract and retain talent. The overall cost of labor remains a significant concern, yet employers are having to increase compensation as the most effective tool to build and sustain strong front
